ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution Janak Raj Mahajan, B.Ed College, Gangath, The. Nurpur, Distt. Kangra, Himachal Pradesh - 176201. has by affidavit consented to come under New Regulations and sought for one basic unit in M.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely.
- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds,(d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31,20153.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (CLU) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015 Building completion be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016 If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- In case any existing institution's matter is sub-judice under court direction/SCN under section17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/ complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be require to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the orer/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- AND WHEREAS, in the light of the above, the Northern Regional Committee, NCTE hereby issued the revised Recognition Order on 22.05.2015 to Janak Raj Mahajan, B.Ed College, Gangath, The. Nurpur. Distt. Kangra, Himachal Pradesh - 176201.for conducting B.Ed. programme of two years duration with an annual intake of 100 for one basic unit of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015
- 5. AND WHEREAS, The matter was considered in NRC in its 256nd (Part-2) Meeting held from 22th to 25nd August, 2016 and the committee decided to curtail the total units of the institution on the following grounds:-

The institution applied for withdrawal of one additional unit of B.Ed. on 24.05.2016 with affidavit on this basis, the NRC NCTE decided to withdraw one additional unit of B.Ed. course.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act. 1993. the Northern Regional Committee hereby refixes the intake of the institution i.e Janak Raj Mahajan, B.Ed College, Gangath, The. Nurpur, Distt. Kangra, Himachal Pradesh – 176201 for B.Ed course one Additional Unit (total 50 student) from two unit (100 students) on the grounds mentioned above. the institution can run only one unit students (50 students) only.

- Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - (a) Sunctioned programmes along with annual intake in the institution.
 - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last quarter.
 - Names of students admitted during the current session along with qualification. Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students.
 - (f) Available infrastructural facilities.
 - (g) Facilities added during the last quarter.
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - (i) The attidavit with enclosure submitted along with application.
 - (i) The institution shall be free to post additional relevant information, if is so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act. Rules. Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the
